- 5. Phone allowance- Youatt discussed an employee stipend for using cell phones.
- 6. Police fiber the initial install date is scheduled for April 6.
- 7. **Water tower-** Air Advantage is looking for another location to move their antennas. Once this occurs, the Village can move forward with the project.
- 8. **State Tax Commission-** Youatt stated that it would cost the Village more in attorney and court fees than the reimbursement amount. The Village will make sure the abatement is off by next year.
- 9. **Meeting Attendance**–Youatt requested Council's input on department heads/employees being paid to attend meetings. Council decided by consensus of the majority that department heads/Village employees would be paid to attend meetings only when asked to attend by the Village Manager. Joe Herrington opposed. However, Council finds it necessary for a police officer not on overtime or an extended shift to stop by meetings and attend or observe. They want the officer to analyze and decide if they need to stay or not. Council is also aware that the officer may need to leave if they get a call.

## **Council Business:**

Joe Herrington states last week, the fire department received a call that a house was flooding. Herrington feels that adding the emergency number along with central dispatch to the website's home page is needed.
